## ISIL 11<sup>th</sup> Winter Course on the Law of International Institutions 3 January 2022 – 7 January 2022 (online classes)

The Indian Society of International Law (ISIL) was founded in 1959 at the initiative of Shri V. K. Krishna Menon and was inaugurated in the same year by Pandit Jawaharlal Nehru, the first Prime Minister of independent India, with the objective to "foster nation-wide the study and development of International Law and to encourage the comparative study of the application of International Law in other States". The ISIL has been publishing *the Indian Journal of International Law* since its inception, which has attained a high standard and is held in high esteem the world over. The ISIL has also a good library, which is used by scholars from all over India. It organizes annual conferences and seminars on international issues of contemporary interest. Finally, and equally important, it conducts and promotes independent research on issues of International Law. The teaching wing of the ISIL- *the Indian Academy of International Law & Diplomacy* - runs post-graduate diploma courses in various branches of international law. The ISIL organises every year a Summer Course in international law to bring to you the current developments and their importance in the field.


From 2010 academic year, the ISIL organizes a one-week winter course every year on specific areas of international law viz., in 2010, the *First Winter Course on International Environmental Law*, *Second to Eighth Winter Course held on topics "International Trade Law 2011", "Private International Law 2012", "Trade and Investment Law 2014", "International Taxation Laws 2015", "Settlement of Dispute under International Law 2016", "International Maritime Law 2017", "International Migration and Refugee Law 2018", "International Law and National Security 2020" and "Air and Space Law 2021"*.

We are pleased to announce the **ISIL 11<sup>th</sup> Winter Course on the Law of International Institutions** which will commence from **Monday, 3 January 2022, to Friday, 7 January 2022**. The topics will relate to: Theories of International Organization, Evolution of the League of Nations and Its Success and Failures, Evolution of United Nations, Relationship between General Assembly and Security Council, Relationship between the Security Council and International Court of Justice, Relationship between ECOSOC and NGO's, Legal Capacity of International Organizations, Privileges and Immunities, Administrative Tribunals, the Law Governing the Activities of International Organization, Succession and Dissolution of International Institutions, Responsibility of International Institutions, Specialized Institutions (WHO, IMF, UNESCO UPU, ITU etc), Interpretation of the Constituent Instruments of the Organizations, Territorial Administration by the UN, Regional Organizations etc.

The Society endeavours to make available the best expertise available in the respective fields as course instructors, which would include noted academicians, governmental, non-governmental and UN officials etc.

The course will comprise classroom lectures, discussion, counseling and library consultation on weekdays. The course fee would be Rs. 3,000/- for students and Rs. 3,500/- for teachers and lawyers. Maximum 300 participants can be admitted on the basis of first-cum basis. Demand drafts shall be drawn in favour of the Indian Society of International Law. Online registration is also placed at ISIL website. At the end of the course a certificate of attendance will be given to all the participants.
