This course provides a brief exploration of arbitration, covering its principles, procedures, and practical applications. Participants will delve into the legal framework governing arbitration, examine the role and responsibilities of arbitrators, and gain hands-on knowledge in conducting arbitral proceedings.

### **Key Topics to Be Covered:**

- Introduction to arbitration and alternative dispute resolution (ADR)
- Legal framework of arbitration: domestic and international perspectives
- Formation and interpretation of arbitration agreements
- Selection, appointment, and role of arbitrators
- Procedural rules and guidelines governing arbitral proceedings
- Conducting evidentiary hearings and submissions in arbitration
- Drafting arbitral awards and enforcing arbitration agreements
- Challenges to arbitral awards and judicial review
- Emerging trends and developments in arbitration practice

This course is designed for law students, academicians, legal professionals, corporate executives, government officials, business professionals, any subject experts and individuals interested in gaining a basic understanding of arbitration as a dispute resolution mechanism. Prior knowledge of arbitration or legal experience is not required; it is a basic introductory course on arbitration

The course will comprise **physical** lectures and discussion, from 10 a.m. to 5 p.m. The course fee would be Rs. 1000/- for students and Rs. 1500/- for teachers, officials, lawyers and others.
